Toyo Tires & West Supply Giveaway

Terms and Conditions

- 1. West Supply and YHI (New Zealand) Ltd ("YHI NZ") the official distributor of Toyo Tires New Zealand have partnered to provide a promotional giveaway.
- 2. These are the terms and conditions ("Terms") which apply to the The Good Times Giveaway promotion ("Promotion"). Information on how to enter the Promotion forms part of these Terms. Make sure to read these carefully as they set out the eligibility criteria, the rules of the Promotion and details of the prize.
- 3. The prize for this competition include:
 - a. Four Toyo Tires Open Country tyres (up to and including 20" sizing. Subject to stock availability. Sizes cannot be back ordered or indented).
 - b. One Feldon Shelter Crow's Nest Regular 2-Person Rooftop Tent
 - c. Front Runner Slimline II Roof Platform (if your vehicle is not compatible for a Front Runner Slimline II Roof Platform, suitable roof racks will be sourced in its place).
 - d. Installation of all of the above prizes onto a compatible vehicle. If the winners vehicle is not compatible, no installation will be offered.
- 4. The Promotion will commence on 19 October 2020 and will close on Friday 6 November 2020 at 11.59pm ("Promotion Period"). All entries must be received before the Promotion Period ends in order to be eligible to win the prize.

Eligibility Criteria:

 - a. Meet all criteria (including the Eligibility Criteria noted below) set out in these Terms throughout the Promotion Period;
 - b. Are New Zealand residents; and
 - c. Are aged 18 years or over ("Entrant").
 - d. Has a full current NZ drivers license.

 - a. Are employed by YHI NZ, West Supply, Front Runner Outfitters or Feldon Shelter;

How to Enter:

- d. Share the Promotion on their Instagram Story.
- 9. The Entrant has the opportunity to create one entry on each giveaway instagram post by Feldon Shelter & Toyo Tires NZ (6 in total).
- 10. The Entrant (including if they are the Winner as noted below) gives YHI NZ & West Supply permission, for an indefinite period of time (unless otherwise advised), to use their name, and any information submitted as part of the Entry, for the purposes of the Promotion only.
- 11. The judges' decision in relation to any aspect of the Promotion will be final and binding on every person who enters. No correspondence will be entered into.

- 14. West Supply will contact the selected Entrant to confirm whether all eligibility criteria are satisfied. If the selected Entrant satisfies all eligibility criteria under these Terms, they will be declared the winner ("Winner").
- 15. If the selected Entrant does not satisfy all eligibility criteria as determined by West Supply, a new Entrant will be drawn in accordance with the above process, and the process repeated, until a Winner is selected.
- 16. To be an eligible Entrant (Winner), the designated person must be a person who:

 - b. Are a New Zealand resident; and

- compatible for a Front Runner Slimline II Roof Platform, suitable roof racks will be sourced in its place).
- d. Installation of all of the above prizes onto a compatible vehicle. If the winners vehicle is not compatible, no installation will be offered.
- 19. If the Winner does not respond within 12hrs of being notified, or if they are found to have breached these Terms, they will forfeit the Prize and another Winner will be selected and contacted in accordance with the above.

- d. To the fullest extent permitted by law, Facebook (including its officers, employees, and agents), will not be liable in any way (including negligence) for any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the Promotion.
- 29. Any cost associated with accessing the app/Facebook platform is the Entrant's responsibility and is dependent on the Internet Service Provider used.

If, for any reason, the Promotion is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failure or any other causes beyond the control of West Supply, which corrupt or affect the administration security, fairness or integrity or proper conduct of this Promotion, West Supply reserves the right in its sole discretion to take any action that may be available, subject to any New Zealand laws and/or regulations.

West Supply will not be liable if the Prize cannot be taken up due to an event not reasonably within its control having exercised reasonable diligence, including but not limited to if there is a fire, storm, flood, earthquake, act of God, war (whether declared or undeclared), acts of terrorism, industrial dispute, blockade, lightning, explosion or meteor event, governmental restraint, expropriation or prohibition.

Except for any liability that cannot be excluded by law, West Supply (including its employees and agents) excludes all liability (including negligence), for any personal injury, or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following:
 - a. any technical difficulties or equipment malfunction (whether or not under the West Supply control);
 - b. any theft, unauthorised access or third party interference;
 - c. any Entry or Prize that is late, lost, altered, or misdirected (whether or not after its receipt by West Supply) due to any reason beyond the reasonable control of West Supply;
 - d. any variation in the Prize to that stated in these Terms;
 - e. any tax liability incurred by an Entrant; or
 - f. the use of the Prize.
- 37. Nothing in these Terms is intended to exclude, restrict or modify a consumer's rights under the Consumer Guarantees Act 1993. These terms and conditions must be read subject to those statutory provisions and will not affect any statutory rights that an Entrant may have in relation to the return of a Prize.
- 38. West Supply, in its sole discretion, reserves the right to cancel, suspend, terminate or modify the Promotion or any part of the Promotion if fraud, technical failures or any other factor beyond West Supply's reasonable control adversely affects its ability to conduct the Promotion or part of the Promotion as contemplated in these Terms.
